

## PRIOR AUTHORIZATION METRICS FOR MEDICAL ITEMS AND SERVICES (EXCLUDING DRUGS)

To comply with the CMS Interoperability and Prior Authorization final rule, Sendero Health Plans is required to annually report aggregated prior authorization metrics on our website. Specifically, this includes a list of all medical items and services (excluding drugs) that require prior authorization, as well as data on prior authorization requests for those items and services (e.g., approvals, denials, etc.) over the previous calendar year. Publicly reporting these metrics promotes transparency and accountability, helps patients understand prior authorization processes and enables providers to evaluate payer performance. Prior to January 1, 2026, impacted payers are required to send prior authorization decisions within the following timeframes:

- 48 hours for Expedited Requests (Urgent) and 72 hours for Standard requests (Non-Urgent)


There are no Medicaid FFS requirements regarding prior authorization decision timeframes for either type of request prior to January 1, 2026, and there are no CHIP FFS requirements regarding prior authorization decision timeframes for expedited requests prior to January 1, 2026.

In 2025, Sendero received 1,304 urgent prior authorization requests for its covered members. 98.77% of those requests were approved, and 1.23% of those requests were denied.
